Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2023-24 educational progress for Ingham Virtual High School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2024-25 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2023-24. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2021-22. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67% in 2021-22. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school has not been given a label as "targeted," "additional targeted," or "comprehensive support and improvement."

After analyzing the Annual Education Report, we are continually working to promote student success through strong communication links between our students, mentor teachers, counseling department and administrators. We have continued to utilize a dedicated facilitator for solely the purpose of connecting with IVHS students.

State law requires that we also report additional information:

- Students are assigned to Ingham Virtual High School primarily by
  - residence/district boundaries. Out of District School of Choice
  - students also attend Ingham Virtual High School by application.
- Ingham Virtual High School annually reviews a continuous improvement plan. This plan is aligned with the district goals.
- Ingham Virtual High School does not have any "specialized schools."
