Resolution for Board Discipline

High School Student 2022-23.2 Monday, November 14, 2022

- 1. The specific misconduct violation(s) found, a preponderance of the evidence establishes that the student engaged in **bringing a dangerous weapon to school**, in violation of the student code of conduct/revised school code section **380.1311**.
- 2. Consideration of the RSC 1310d seven factors
 - a. Age;
 - b. Disciplinary history;
 - c. Whether the student has a disability;
 - d. The seriousness of the violation or behavior;
 - e. Whether the violation of behavior threatened the safety of any student or staff member;
 - f. Whether restorative practices will be used to address the behavior; and
 - g. Whether a lesser intervention would properly address the violation or behavior
- 3. Enter length of disciplinary removal: Ten (10) Days
- 4. Any precondition(s) that must be satisfied for reinstatement at the end of the expulsion/suspension period: success in completing teen court.
