COMMENTS AND/CONCERNS OF CITIZENS PRESENT:

JoAnn Isham, Race Street, Leslie shared her concerns regarding the preschool, GSRP and Head Start Programs being able to meet the LARA guidelines of less than ten students and distancing six feet apart.

Desiree Smith, Churchill Road, Leslie, shared that she has heard that the basics of the programs are being offered for students. Were teachers given an option of in-person or online?

Ranee Bradish, DeCamp Road, Stockbridge, questioned whether students who have chosen the online option if it will continue after October 1?

Superintendent Manthei shared that as long as a student meets the 50D requirements they can remain online for the entire school year.

Jason Tello, State Road, Leslie, questioned why a hybrid plan was not offered; are Ipads and Chromebooks available for students; what the transition plan would look like if online turns into in-person learning.

Jane Weck, Covert Road, Leslie shared she has four children in the school district and they have chosen online learning due to significant family health concerns. She also questioned if the parent surveys could be shared.
